#### **SECTION 4 — FIRST AID MEASURES**

Flinn Suggested Chemical Storage Pattern: Inorganic #5. Store with sulfides, phosphides, carbides, and nitrides. Keep container tightly closed. Moisture sensitive material; must be stored away from any source of moisture and away from any acid. Store in a Flinn Chem-Saf bag and then inside a Flinn Saf-Stor can.
